

## Terms and Conditions

BY ATTENDING THIS & FUTURE EVENTS YOU AGREE YOU HAVE READ & UNDERSTOOD AND WILL ABIDE BY THE CLAUSES AND CONDITIONS SET OUT.

1. NO REPRO OR NEW GOODS
2. Aztec supply wooden trestle tables. Check on arrival that your table is correctly and safely opened, as Aztec Shows LLP cannot be liable for any breakages. CHAIRS ARE NOT SUPPLIED.
3. WRIST BANDS / CAR PASSES - Please ensure you wear your exhibitor wrist bands at ALL times and that your car park pass is clearly displayed on your windscreen at all times. There is no re-issue of car passes unless a further pitch is paid for. Your car pass is your responsibility and no entry will be permitted to the show ground with out a valid car pass. No car is permitted onto the showground without a valid car pass.
4. Watch your stock at all times as Aztec Shows LLP will not be held responsible for any loss or theft from your stall. Stall holders are reminded of the importance to obtain their own insurance cover.
5. At no times must goods block the aisles – ALL aisles must be at least 2m wide. You must not move your table forward or place any goods or tables of any kind in the public walkways. All stands must stay within the area booked - No extra tables are to be put in the gap between the tables and a double stall is two tables joined with no gap in the middle.
6. The maximum electricity load for lighting purposes is 200 watts. Aztec Shows LLP. Cannot be held responsible for any loss of power. Aztec DO NOT supply extension leads. All extension leads must be P.A.T tested. NO KETTLES OR HEATERS PERMITTED
7. FAILURE TO ATTEND: Please note that all fairs must be pre-paid. If for any reason you have not paid in full for a fair and subsequently fail to arrive, the stall rent will still be due and an invoice will be issued and forwarded to you for the full amount outstanding.
8. CANCELLATIONS: Cancellations will be accepted up to ONE calendar month before the fair. Any booking cancelled less than ONE month's notice before the fair for whatever reason will forfeit the total stall fee paid even if we re-let the stall. Cancellations may be advised by phone but must be confirmed in writing. All deposits are non-refundable. In the event of Aztec having to cancel an event, Aztec is not liable for any costs incurred by the exhibitor. Please Note: Loyalty Bookings are Non-Refundable.
9. TRANSFERRING A PAYMENT: Money can only be transferred to a future fair up to one month prior to the event cancelled.
10. Booking only confirmed on receipt of full payment. If payment has not been received by due date booking is void.
11. To comply with Trading Standards regulations all stall holders must ensure that all goods are clearly priced. Aztec reserves the right to ask stall holders to remove any goods considered unsuitable. For identification purpose all stall holders must wear the wristbands provided.
12. Exhibitors note: You are responsible for the safety of your stand and refer you to sections 2 above. Exhibitors are totally responsible for every object displayed by them including liability for all claims arising out of handling of objects. Exhibitors shall indemnify Aztec Shows LLP. Acceptance of the above shall be condition of entry to the event. Aztec Shows LLP. Will not assume any responsibility whatsoever for any loss, damage, abandonment or cancellation of any event.
